PERSON-CENTRED APPROACH

Log participants' information-sharing preferences and share the vision — sensitively. Let the team know what it's aiming for and create a historic record that keeps the vision alive.

ORGANISATION & ATTENTION TO DETAIL

There's so much going on in an ILO project. The ILO KIT ensures you've covered all the NDIS requirements — including for the Service Proposal. Keep everything in one place and everyone in the know.

LEADERSHIP & TEAMWORK

Manage risks of all kinds — from medical conditions, to privacy, to supporter understanding. Includes risks to participants living alone with support from a single worker. And it ensures risk treatment strategies are reviewed and improved where necessary.

SUPPORTS IMPLEMENTATION

A clear picture of how your team delivers support — who is on the team, their role, contact data, access to information, scheduling and agreements. A suite of tools to build the team and their capacity.

SUPPORTS & LIVING ARRANGEMENT REVIEWS

Create a historical record of improvement strategies. Make sure the ILO keeps delivering and stays safe for the participant, year after year.



ILO POLICY & PROCEDURE

Clear and methodical, the *Individualised Living Options Policy and Procedure* guides staff through the ILO process — eligibility, exploration and design, support provision, recruitment, training and reviews — including all essential compliance requirements and provider obligations. Note that the policy assumes your organisation has processes in place to address the risks involved in the ILO supports you deliver.

LIVING ARRANGEMENT TOOLS

Finding the right living arrangement means recruiting the right people, working with them to understand the goals, needs, supports and risks involved. Simplify the process with these easy-to-use tools — and maximise participant safety.

HOST, MENTOR & HOUSEMATE REGISTER

Match applicants to participants' needs and goals. Keep track of recruitment efforts and manage Quality and Safeguards too — use it in conjunction with the included *Host Home Safety & Wellbeing Checklist*. Easy and effective!

AGREEMENT TEMPLATES

Clear agreements in simple, friendly English. Make sure everyone understands their roles, rights and obligations. NDIS Participants, ILO Providers, Primary Hosts, Secondary Hosts, and Housemates. These templates provide a reliable foundation — save hours of work each time you use them.

HOME SAFETY & WELLBEING CHECKLIST

Treat the house like a home, not a factory. Think about privacy, spaces for solitude, communal activity and relaxation, access to and from the community. Of course, this checklist does WH&S-style safety too, but with common disability sector risks in mind. Conduct preliminary checks, monitor ongoing safety — and more.

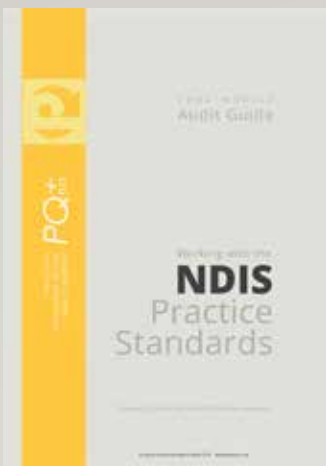

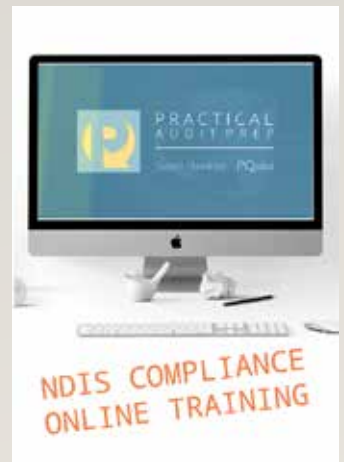
